



## New Space, Resources lead way with FV Integration Project

A range of new initiatives are underway to improve services responding to family violence at Ringwood Magistrates' Court. Involving numerous agencies, the developments have been facilitated and encouraged by the progress of the Family Violence Integration Project (FVIP), a new and innovative partnership project led by ECLC and funded by the Legal Services Board.

While still early, these improvements have been driven by strong consultation with women who have experienced the Court system and the agencies working at the Court. An early issue identified was a lack of separate waiting areas for people attending the Court, extending the fear of violence and lack of safety to the actual Court experience. With the active support of the Court, the Police Family Violence Liaison Officer, agencies and the project, a separate waiting space has now been established at the Court for vulnerable women and children.

The Project's Vision is to instil trust and confidence in the most vulnerable of victim/survivors that their safety and support needs will be upheld through their interaction with the legal components of the family violence system.

Its aim is to improve the response of legal and support services to victim/survivors of family violence in a coordinated and integrated manner, through the partnership and collaboration of key agencies working at the Ringwood Magistrates' Court.

## FVIP Achievements

The project commenced with a consultation phase that successfully identified the integral issues for victim/survivors of family violence through their experience of applying for an Intervention Order:

- Limited access to information
- Limited support
- Risks to safety and privacy
- Limited legal response
- System issues
- Agency issues

The project also identified some key elements to an 'effective legal response'. These all informed the Recommendations for improving the Court experience for victim/survivors of family violence.

Some of the achievements of the FVIP so far have included:

- Improved relationships and collaborative practice between the services involved at the Ringwood Magistrates' Court.
- Protected Persons Space - a safe and comfortable waiting area for victim/survivors of family violence that is separate to the main waiting area.
- Increased information available for service providers
- IOSS Roles and Responsibilities document
- IOSS Guide
- Increased information available for Court users
- 'Commonly Asked Questions' - Court Information Sheet
- 'Results letter' (summary of the legal outcome with added information to be provided by the legal services)


The Mayor stated, "We're confident this free guide will be a great asset to many in our community. It's an excellent book and I congratulate them highly."





## ECLC at the National CLCs Conference

Building on the theme 'Rights, Representation and Reform', the 32nd National Community Legal Centres Conference took place in Hobart this October, with the ECLC team and all the Centre's hard work well-represented:

- Michael Smith (CEO) opened and 'MCed' the conference in his role as Convenor of the National Association of Community Legal Centres, but also managed to fit in a workshop on the application of primary legal interventions to reduce the risk of elder abuse, co-presenting with Sonya Mitchell, a social worker from Townsville CLSs seniors program;
- Amy Johnstone (Community Development) facilitated a session on Asset-Based Community Development at the Community Legal Education Workers pre-conference network meeting, exploring ways to incorporate new approaches to community development into the work of CLCs;
